I-4 East to Kirkman Rd. Head N on Kirkman Rd. to MetroWest Blvd. Make a left onto MetroWest Blvd. We are located in a one-story red brick building on the right side of MetroWest Blvd just past the Walmart and apartment entrances.

Directions from North Orlando:

I-4 West to John Young Pkwy. Turn right onto John Young Pkwy and continue immediately right onto L.B. McLeod. Take L.B. McLeod to Kirkman Rd. Turn right onto Kirkman Rd. Take Kirkman Rd to MetroWest Blvd. Make a right onto MetroWest Blvd. We are located in a one-story red brick building on the right side of MetroWest Blvd just past the Walmart and apartment entrances.
